The Board will conduct a Public Hearing on whether to adopt a Resolution to place a District Parcel Tax Ordinance on the November 5, 2019 ballot for determination by District voters, including the proposed tax rates.

RESOLUTION OF THE BOARD OF DIRECTORS OF THE GOLD RIDGE FIRE PROTECTION DISTRICT CALLING A SPECIAL ELECTION FOR TUESDAY, NOVEMBER 5, 2019, ON AN ORDINANCE AUTHORIZING THE DISTRICT TO IMPOSE AND LEVY A SPECIAL TAX TO ASSIST THE DISTRICT IN MEETING THE COSTS OF CONTINUING TO PROVIDE AUTHORIZED FIRE AND EMERGENCY SERVICES AND EXERCISING OTHER RIGHTS AND POWERS OF THE DISTRICT, INCREASING THE DISTRICT'S APPROPRIATIONS LIMIT FOR THE MAXIMUM PERIOD ALLOWED BY LAW TO ALLOW THE USE OF THE PROCEEDS OF THE SPECIAL TAX, AND REQUESTING THAT THE ELECTION BE CONSOLIDATED WITH ANY OTHER ELECTION HELD ON THE SAME DATE IN THE SAME TERRITORY

Director Tachouet stated that the total is \$265.00 though it is noted at \$200.00. Mr. Adams mentioned that the \$265.00 is not for this ordinance. Chief George mentioned that we are stating the new tax would be \$200.00 on top of the \$65.00 in place, for a total of \$265.00.

Chief George mentioned we will update our website, and Mr. Rosatti stated we will be sponsoring two events that will have all the facts laid out. Chief George stated we will be having two meetings. One will be at Hessel Church and the other one will be held at Twin Hills School.

Director Lachman asked Mr. Adams if we should be concerned that no public attended. Mr. Adams stated "no", though we need to get the message out regarding the new parcel tax.

A motion was made by Director Tachouet to adopt Resolution 19/20-02. The motion was seconded by Director Doyle and passed unanimously.
